



Tom Berry became a member of the Garces community when he married Garces alumna Mary (Anspach) Berry '79, and he has been an advocate for Catholic education in general, and of Garces Memorial specifically, ever since. Tom and Mary met at Creighton University and, once Tom finished dental school, they moved to Bakersfield in 1987 to start their family. They have three children who are also Garces graduates – Katie (Berry) Grimm '05, Michael Berry '08, and Annie (Berry) Carlson '12. Each of their children have married Garces alumni as well – Katie is married

to Brandon Grimm '00, Michael is married to Kelly (McDermott) Berry '08, and Annie is married to Dominic Carlson '12.

As Tom and Mary's children became Garces Rams, they both became very involved on our campus. Mary volunteered and helped with Gala – which meant Tom was also a volunteer. When Michael was on the football team, Tom was one of the "paint dads" – showing up to paint the field before each home game. They came to every event their children participated in and became beloved fixtures at Garces.

Tom was asked to be on the Garces Memorial School Board, and he served as a board member for nine years. During his tenure as a school board member, Garces saw the addition of the Campbell Field House, the refurbished stadium seating at Sam Tobias Field, the Cerro Science Building, the St. Dominic Student Chapel, and an electrical upgrade to the campus. Tom was also a committee member of the Fund the Future Capital Campaign, helping to raise \$6 million dollars for the improvement of Garces which resulted in, the Salvucci Aquatics Center, the Garces Tennis Complex, and the Art of Music Building.

When Tom rolled off the Garces School Board, he was asked to join the Garces Foundation Board, which is now known as the Bakersfield Catholic Education Foundation. He has been on the Foundation Board since 2010 and is currently the President of the Foundation. As such, he has helped the Foundation assets grow from \$2.34 million to \$16.06 million dollars resulting in a substantial annual allocation to Garces Memorial. The Foundation funded the initial iPad program for Garces and currently provides funding for tuition assistance scholarships, teacher development, and a breakfast and lunch program for families in need of assistance. Under Tom's leadership, the Foundation established the new STEM room at Garces complete with new computers and a designated space for the Robotics program.

Tom, along with his wife Mary, have been generous supporters of Garces. He has been a long-time supporter of the Garces Gala, the Garces BBQ, and the Monsignor Leddy Golf Tournament. He has given generously to the Annual Fund Drive and to the Alumni Scholarship Fund. And he spearheaded a Foundation Board Member Scholarship Fund to assist students to come to Garces.



Joan (Haller) Finch '87

Introduction by Alumni Board Member Raji Sanghera '87


Joan Finch graduated from Garces in 1987 and was one of six "Haller" siblings to attend Garces Memorial. Joan's mother, Helen (Reischmann) Haller was a 1957 graduate and providing her children a Catholic education was of paramount importance to her. Joan siblings are Mary Kay (Haller) Link '82, the late Barbara (Haller) Boylan Schager '83, Dianne (Haller) Peranich '84, Katie (Haller) Metcalf '90, and Daniel Haller '91. While at Garces, Joan excelled in volleyball, girls basketball, and track and received all-league honors for athletic abilities. Joan still holds the triple jump record

at Garces. Joan was also voted Homecoming Queen her senior year. Joan's athletic ability earned her a college scholarship, and she went on to play volleyball at Cal State Bakersfield. Joan married her husband Jeff in 1989 and they have three wonderful children who are also Garces graduates – Jordan Finch '10, Justin Finch '08, and Julianne Finch '16.

Joan initially came back to Garces to substitute teach and coach volleyball and was hired by Dr. John Ritter in 2004 as a full-time teacher for PE and Health. She also continued to coach volleyball and the track team. Joan was appointed the Garces Athletic Director in 2014.

As the Garces Athletic Director, Joan made huge strides with the CIF and the KHSD. Her fellow AD's in the CIF Central Section voted Joan as the recipient of the 2016 California State Athletic Directors Association's Norm MacKenzie Award as the Athletic Director of the Year. Joan hired our first full-time Athletic Trainer and was one of the first to fully utilize the iPad program at Garces. She put Garces Athletics on-line, making athletic forms, schedules, rosters, release times, game locations, final game scores, etc., accessible to everyone. She took over the Booster Club and set funds aside for the refurbished the gym floor and provided new seating for the players and coaches. She was instrumental in the new sod for the football field. She worked closely with the Hail Mary Club on the refurbishment of the Campbell Field House. She easily worked an 80-hour week on behalf of the students, coaches, and families at Garces. Joan is well-respected by all and remains an exceptional ambassador for Garces.

When the Garces Alumni Board was re-established in 2009, Joan was the faculty representative for the first three years. When Joan's husband Jeff retired in 2017, Joan decided to join him and she retired from Garces in 2018. Joan is a faithful Catholic who lives her life with integrity and grace. For several years, Joan continued to volunteer to help Garces and you could often find her helping out at cross country and track meets. On occasion, you will still see Joan at a Garces football game or a soccer game with her grandchildren in tow. And currently you can often find her on-campus, as she is substitute teaching at Garces this school year.



Ed Hearn

Introduction by Alumni Board Member Courtney Tobias '92

Ed Hearn joined the administrative team at Garces Memorial

in 1991, at a time when the school was experiencing a sharp decline in enrollment and needed a change in leadership and direction. He spent five years at Garces setting the gold standard for future administrations as much of what Garces Memorial represents today was due to his vision. When Ed arrived at Garces, he was unaware that the school had a 2.5 million dollar debt to the diocese and upon arrival, he was given six months to bring the school into the black. Following that stumbling block, a plan was created to repay the debt by the time Ed left five years later. Also at this time,

the school implemented a new administrative model and he

was appointed the President/Principal, implementing a restructuring effectively used in several successful Catholic schools across the country. In his role, Ed implemented several changes for the betterment of Garces. One of the most significant was a more definitive and focused model for Catholic education that enhanced the identity of Garces as a Catholic, co-educational, college preparatory school. In October 1991 Ed launched the Parent Pledge program which he continues to practice to this day in his capacity as a school President.

In addition to providing the guiding philosophy and direction of Garces, Ed was responsible for many improvements at the school. The school significantly improved its academic offerings by adding new Honors and Advanced Placement courses, a summer reading program, summer school and a study skills program for incoming freshmen. Instructors were encouraged and financially supported to attend in-service training to improve instructional delivery. Ed worked with the late Johnny Etcheverry cleaning, sanding, and preparing the wrought iron fence that surrounds our campus to this day. Buildings were painted inside and out, classroom floors were carpeted, new roofs were installed, the parking lots resurfaced, and a new concession stand was built. Athletic fields were also improved and the marquee on the corner of Union and Columbus was installed Under Ed's leadership, Garces developed the 2010 Plan which was a road map outlining the future direction and needs of the school. The 2010 plan was published in January of 1995 and prioritized the school's needs into either physical plant or school operations. Many of the changes to our campus are a result of the 2010 Plan — including the library, the administration office, the concession stand, and the fence surrounding the school.

Ed left Garces in 1996 to become the Principal of Brophy College Preparatory, a private Jesuit, Catholic school in Phoenix, Arizona. In 2006, Ed became the president of St. Augustine High School in San Diego, California, where he currently continues to provide exceptional leadership in his role as their president.

In 2016, Ed came back to Garces to provide leadership and guidance on the Garces Memorial 2018-2024 Strategic Plan. Ed drove up from San Diego numerous times over several months to lead discussions with the planning committee members about the future needs and objectives for Garces Memorial. His insight and moderating abilities were invaluable in creating the final document that the school is using today.

Ed received his BA from Loyola University of Los Angeles and his MA from California State University Los Angeles and has spent over 50 years in education. Ed is married to Diana, they celebrated their 50th anniversary in 2021 they have three boys, Nate, Conor and Mark two grandchildren with a third one due today.



Jenny (Maitia) Poncetta '70'

Jenny (Maitia) Poncetta graduated from Garces in 1970 and has remained a loyal supporter of Garces ever since. While at Garces, Jenny was a member of the ski club, the Basque club, and yearbook.

At a young age, Jenny went into the family business of running Wool Growers Restaurant where you will find her almost daily attending to her customers and her staff. It is truly a family business, one that she ran with her mother, Mayie Maitia, and her brother Danny Maitia, until their passings. She currently runs the business with her daughter Christiane (Arduain)

Camou '93. Wool Grower's is a must stop for our alumni and families and over the holidays you will find Garces families catching up with Jenny and other alumni as if it was a Garces reunion.

Jenny sent both her her daughter's to Garces, Christiane (Arduain) Camou is a 1993 graduate and her daughter Natalie (Arduain) Sorhouet graduated in 1998. Currently Jenny's granddaughters Gabriella Camou '23 and Sophia Camou '25 attend Garces. Jenny was a presence on campus when her daughters were at Garces and is a presence now that her granddaughters are here – supporting her granddaughters in their theater performances, rooting for them during a soccer game, or attending Grandparents' Day.

Jenny has always proudly supported her alma mater. She has generously given in support of the Fall BBQ, the Garces Gala, and the Hall of Honor. She has donated food from her restaurant and donated the bar and the proceeds to the Hall of Honor awards dinner. In addition to donating her resources from the restaurant, she has underwritten many of our special events, the football program, the girls soccer program, the drama program, and our FFA program. She served on the Garces Alumni Board for three years and helps to plan the 1970 Class Reunions. She supports the Alumni Scholarship, the Gino Colombo Scholarship, and the Annual Fund Drive. Most recently, she is in the process of establishing a tuition assistance scholarship in memory of her mother to assist others to obtain a Catholic education at Garces.

She is a strong Catholic, practicing her faith in word and in deed. She is an active member of St. Elizabeth Ann Seton Church and St. Francis Church. She is a member of the Kern County Basque Club and was formerly on the St. Francis Church Finance Council. Her support of Catholic causes is infinite. Jenny is married to David Poncetta. David's children are also Garces graduates – Melissa Poncetta '97 and Michael Poncetta '00.
