Tuition: The 2022-2023 tuition rate for International students is \$18,000. The full tuition amount must be received by June 1. 2023.

Tuition Adjustment Policy: Refunds are not allowed on tuition and fees for International students.

Financial Delinquency: Payments received later than the 5^{th} day of the month in which they are due will incur a late payment penalty of **\$40.00**. Checks or Electronic Payments returned to the school for non-sufficient funds will be charged a **\$25 NSF fee**. The school reserves the right to refer accounts 30 days past due to collection, in which event you will also be responsible to pay any applicable collections costs and/or attorney fees otherwise incurred by the school. **Students with past due accounts may be subject to Suspension or Recommended Transfer unless a written arrangement concerning the payment of the past due**

amount(s) is otherwise agreed to by the Carces Memorial Business Office. All tuition and fees for Senior students must be paid in full by May 1, 2024 in order for the student to participate in Baccalaureate/Graduation exercises.

Other Payment Information:

- All students must pay a non-refundable **Registration/Activity Fee** of \$500 by May 1, 2023.
- A non-refundable International Fee of \$2,000 per student is due by June 1, 2023.
- A non-refundable one-time iPad Fee of \$600 for incoming Freshmen/transfers is due by June 1, 2023.
- A non-refundable **Student Services Fee** (non-refundable) \$300 for First Year Students, \$550 for returning students is due by June 1, 2023. This fee includes returning student technology fee, student retreat fee (except Kairos), graduations fee, ASB fee, yearbook fee, PSAT testing, parent club fee, parking Fee, CPR training & Certification fee, and miscellaneous classroom material fee.
- Payments may be made by cash, check, Electronic Fund Transfer, or credit card (Visa, Master Card, or Discover Card). On-line payments may be made through the Garces Memorial website at <u>www.garces.org</u>. For EFT payments, contact the Business Office.
- Additional fees may be charged for certain activities including Kairos, Athletic Participation, Band, Bus Transportation, AP testing, book rental, and club fees. These fees will be billed to you when applicable and are due upon receipt.
- This Contract must be returned to the Business Office by <u>June 1, 2023</u>. No student will be allowed to begin the academic year without receipt of full payment, completed Enrollment packet, and Contract on file.

Entire Agreement: This Contract, together with the provisions of the 2023-2024 Parent-Student Handbook, constitutes the entire agreement between you, Garces Memorial High School, and the Diocese of Fresno concerning the subject matter hereof and supersedes all contemporaneous or previous written or oral agreements, representation and undertakings.
